6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.

7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bye-laws, direction issued from the to time and the law if the land.

8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labor Laws etc. With respect to the school and staff of the school.

9. That the school will ensure that the Building Safety, Fire Safety, Water Safety Health and Hygiene certificate are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed them.

State pattern classes IX to XII will be closed in a phased manner. No admission will be taken in the state Board Pattern classes IX to XII after getting affiliation from CBSE. The State Board School Will be Discontinued after switchover to CBSE.
